The Karuk Tribe requests proposal for the following Scope of Work for qualified vendors to provide Karuk Traditional Song instruction for the Ikmaháchraam Project (Eng. *sweathouse*). <u>Each</u> <u>Contractor will be compensated \$100 for each event</u>. Contractor will not be required to share performing privileges of private or family owned songs to the workshop participants, but should instruct on the rules guiding song rights. The contractor will teach at least one communally owned song to the participants, however.

Task One - Workshop Song Lessons

At one of the five workshops associated with this project, contractor will lead workshop participants in learning about the Karuk Oral Tradition of song as most likely used during a traditional sweat.
