Responsibilities:

- 1. Manage the deployment, monitoring, maintenance, development, upgrade, and support of the property IT systems, including servers, PCs, operating systems, hardware, software, and peripherals.
- 2. Oversee provision of end-user services, including help desk and technical support services.
- 3. Resolve user complaints, research issues, answer technical questions; assist with new projects and initiatives.
- 4. Troubleshoot user problems with application software and hardware.
- 5. Supervise and Evaluate the IT Technicians; maintain staff works schedule; coach and mentor.
