The Karuk Tribe seeks food service proposals in support of the 19th Annual Karuk Tribal Reunion to be held July 11, 2015. The Reunion will be held in Happy Camp, California, at the Karuk Tribe Happy Camp Administration Complex.

The Tribe's kitchen will be available to bidders for food preparation and cooking for dinner to be served at the Karuk Tribal gym and for breakfast to be served in the Karuk Tribal gym. There will be tables and chairs for dining.

Food will need to be served buffet style to aide in the fast flow of guests. Respondents will be responsible for recruiting volunteers to help with preparation, serving, and cleaning. Access to the gymnasium and kitchen is available for the entire weekend of the event including Friday.
