The Karuk Tribe requests proposals to have two walls with doors built in two separate hallways at the Karuk Child and Family Services located at 1515 S Oregon St, Yreka, CA 96097.

Task One

To frame in a wall in east to west hallway. Wall is to be finished from floor to 7' height, leaving 1' at top of wall open for HVAC ventilation. Wall to be drywall finished, textured and painted to match existing walls. One 3'6" door with locking hardware with panic bar. Door to match as close as possible existing doors. Baseboard and trim to match existing walls.

Task Two

To frame in a wall in the north to south hallway. Wall to be finished from floor to 7' height, leaving 1' for HVAC ventilation. Wall to be drywall finished, textured and painted to match existing walls. Double 3'6" doors with locking hardware and panic bar. Doors to match as close as possible existing doors. Baseboard and trim to match existing walls.
