Summary:

Troubleshoot slot machines and other gaming & non-gaming related equipment. Perform all types of repairs to correct mechanical, electrical and electronic failures. Have expertise in accounting system operation and troubleshooting, slot machine operation and troubleshooting, ticket in / ticket out system operation troubleshooting, and parts system maintenance.

Responsibilities:

1. Properly diagnose faulty equipment to the circuit board component level.
2. Attain a working knowledge of how to read and understand electronic schematics.
3. Must be able to understand AC/DC theory including the ability to identify wire color codes, resistor ratings, capacitors, transistors, transformers, IC's, etc.
4. Safety and effectively operate shop tools including hand tools, soldering equipment, electronic test equipment and other equipment as required.
5. Analyze and perform major overhauls, routine maintenance and modifications.
6. Complete machine moves and installs including setup and release of the game for play, as well as other projects assigned with little or no supervision.
7. Maintains proper documentation on department repair logs, shift logs, pm logs, M.E.A.L cards, etc.
8. Adhere to departmental and casino policy and procedures.
9. Ensure compliance with all Gaming Regulations and Ordinances.
10. Expertly understand and use the Technical Operations parts system. Always communicate equipment repair and parts requirements to the Tech Supervisor.
11. Provide information and explain Players Club benefits, property amenities & marketing programs to our guests.
12. Communicate effectively both orally and in writing.

13. Shall be polite and maintain a priority system in accepting other position related job duties as assigned.

WORKING CONDITIONS & ENVIRONMENT

5. Ability to interpret an extensive variety of technical instructions in mathematical or diagram form and deal with several abstract and concrete variables.
6. Knowledge of electrical circuitry, electronics and mechanical devices.
7. Ability to learn new mechanical and electrical systems.
8. Must possess reasonable ability to communicate in English.
