The Karuk Tribe requests proposals for the following Scope of Work required for development and safety of the Klamath Riverside RV Park in Orleans, CA.

1. The Karuk Tribe requests lump sum price quotations for all necessary materials, labor, equipment, and tools needed for tree trimming, removal, and clean up at the Klamath Riverside RV Park, 37695 State Highway 96, Orleans, CA 95556.
2. Contractor shall be responsible for assessing all trees within the RV Park for hazardous limbs and unhealthy trees.
3. Contractor must include with any tree removal, making sure the hole is backfilled and compacted with native soil after complete removal and leveled to the original grade.
4. Any ground disturbance, such as that in the task above, will need to be coordinated with the Karuk DNR to have a cultural monitor present.
5. Contractor is responsible to clear the jobsite of debris resulting from the tree and stump removal and will be held responsible for any damages done to the adjacent properties.
6. Contractor shall be properly licensed and insured for the work to be completed.
