2. Ensure compliance with existing internal and external income control policies and procedures.
3. Report income control violations to the appropriate department and recommend correctional action.
4. Monitor and report all items which do not fall within sound auditing or accounting procedures.
5. Audit Slots, Table Games, and Food & Beverage, Hotel, and Gift Shop revenue.
6. Establish and maintain files and records.
7. Update any policies and procedures for various audits directed by the CFO.
8. Provide information and explain Players Club benefits, property amenities & marketing programs to our guests.
9. Provide courteous service to our guests and be cordial to all Team Members.
10. Communicate effectively both orally and in writing.
