The Karuk Tribe requests proposals for the following Scope of Work required for the roofing and gate installation at the Tishániik Farm in Orleans, CA. The **Shield Up roof model #GB36SP** will be installed over two 40'x 8' **High Cube Conex** boxes with a 20-foot space between them. The Shield Up roof with hardware has been purchased and will be provided for installation but the contractor will need to provide the equipment to install (likely a boom lift). Prior to the roof installation the Conexes will need to be squared and leveled which is likely a matter of minor adjustments. Gates on either side of the structure should be built into this proposal total. Gating should be solid or sheet metal clad, and welded or otherwise securely attached to the Conex boxes and fully opening from the center to provide full access to the 20-foot opening.

**Task 1:** Install the provided Shield Up Roof model #GB36SP (including squaring and leveling the existing Conexes).

**Task 2:** Purchase, fabricate (if necessary), and install gates on both sides of the structure.

**Responses to this Request for Proposals should include the following:**

- 1) A statement of qualifications, including relevant project history.
- 2) A proposed approach and rationale for completion of the contract tasks described above, including descriptions of similar work previously completed and the results/benefits achieved.
- 3) A lump sum price, with attached price page.
- 4) Names and telephone numbers of three client references.
