The Karuk Tribe requests proposals for the design and installation of a playground that caters to children of various ages and supports outdoor play and recreation. This project aims to create a safe, engaging, and accessible recreational area for children and families and shall be installed near Hillside Road, Happy Camp, CA 96039. The playground will be part of a future housing development that will initially include eight (8) homes and have an additional four (4) homes in the future.

The project will include, but is not limited to the following elements:

- **Play Structures:** Age-appropriate play structures for varied age groups. Installation of separate play areas for younger (ages 2-5) and older children (ages 6-12). Equipment must meet all safety standards and regulations.
- **Sod Surface:** Installation of a safe and sustainable sod surface. Installation of sod around the playground area to enhance aesthetics and safety. Integration of natural elements to promote outdoor play and learning.
- **Water System:** A sprinkler or water play system for maintaining landscaping
- **Garbage Cans:** Strategically placed to encourage cleanliness.
- **Lighting:** Adequate lighting for safety and usability during evening hours.
- **Amenities:** Design and installation of a BBQ area with appropriate safety measures. Construction of a gazebo to provide shaded seating for families. Benches and Tables: seating for families and caregivers.
- **Fencing:** Secure fencing to ensure the safety of children.
- **Disabled Access:** Compliance with ADA standards to ensure accessibility for all.
- **Security Cameras:** Installation of cameras for enhanced safety and monitoring.

Evaluation Criteria:

Proposals will be evaluated based on:

- Quality and creativity of design.
- Experience and qualifications of the company.

- Cost-effectiveness and value.
- Commitment to safety and accessibility.

Responses to this Request for Proposals should include the following:

- 1) A statement of qualifications, including relevant project history.
- 2) A proposed approach and rationale for completion of the contract tasks described above, including descriptions of similar work previously completed and the results/benefits achieved.
