The Karuk Tribe requests proposals for the following Scope of Work required for the removal and disposal of the existing wire fencing and installation of new 6ft vinyl privacy fencing. The fencing will need to include replacement of a vehicle entrance gate as well as two pedestrian access gates. There is approximately 435 feet of total fencing that is needed, not including the three gate access points. The vehicle access gate is 12'1" and pedestrian gates are 5'3". (See attached map for additional insight).

- Removal and disposal of existing wire fencing
- Removal of vehicle access gate
- Removal and disposal of two pedestrian access gates
- Installation of 6-foot vinyl privacy fencing
- Installation of vehicle access gate
- Installation of two pedestrian access gates
