The Karuk Tribe requests proposals for the following Scope of Work required for provision of a one day, multiple session workshop for the purpose of strengthening cultural awareness, increasing self-esteem and providing healthy alternative activities for Karuk children, youth and families. Workshop session will focus on health and healing cultural activities for participants. The project is to be developed utilizing the Two Generation model of investment in our tribal communities with focus on child/youth and parents.

Task One - Workshop Design and Curriculum Development

Coordination with Karuk Cultural Leaders and design of event activities.

Task Two - Provision of Redwood Canoes and transporting to workshop site and set up.

Contractor is responsible for provision of traditional red wood canoes, transportation and set up and provision of life jackets for participants. Instruction and teaching regarding the metaphysical relationship between Canoes and health and healing for participants.

Task Three – Cultural Presentations and Activities

Cultural Presentations to include regalia design and construction, beading, traditional tools, language, basket making, traditional foods and instruction on preparation of salmon and acorns, traditional card games and brush dance instruction.

Task Four – Provision of Cultural Advisors

Contractor will coordinate all contacts with cultural practitioners/advisors for the event.

Responses to this Request for Proposals should include the following:

- 1) Contractor shall have sufficient demonstrated experience in coordinating and facilitation of the complete workshop.
- 2) A proposed approach and rationale for completion of the contract tasks described above, including descriptions of similar work previously completed and the results/benefits achieved.
- 3) A lump sum price, with attached price page.
- 4) Names and telephone numbers of three client references.
