The Karuk Tribe requests proposals for the following Scope of Work from qualified professionals on Trauma Informed Care in Tribal Communities. The training will take place in tribal facilities located within the tribal communities of Happy Camp and Yreka in Siskiyou County, California.

Task One – Provision of an overview of Historical Trauma and the effect on treatment and the healing process for tribal community members to tribal employees.

Task Two – Provision of culturally competent assessment and treatment plan for tribal behavioral health, child welfare and other staff members working with tribal community members with a focus on trauma informed care.

Task Three – Provision of the use of traditional teachings and ways of healing in tribal community populations.

Responses to this Request for Proposals should include the following:

- 1) A resume and statement of qualifications, including relevant project history.
- 2) Provide a detailed and precise discussion, including examples and/or documentation of meeting each requirement outlined in this RFP.
- 3) A proposed approach and rational for completion of the contract tasks described, including descriptions of similar work previously completed and the results/benefits achieved.

 - b. Direct Expenses Payment will be made by the Karuk Tribe of direct expenses actually incurred by the Contractor in performance of the Contract.
