The Karuk Tribe requests proposals for the following Scope of Work required for provision cultural competency training workshops for the Karuk Human Services Department located at 1515 S Oregon Street in Yreka, California. The training should be presented at a level appropriate for Behavioral Health and Child Welfare Program professionals serving Karuk and other tribal community members. The training may be held virtually via secure platform provided by the Karuk Tribe if desired.

# Task One - Workshop Design and Curriculum Development

# Task Two – Facilitation of Training for Behavioral Health Professionals

- 2. Increase understanding of Karuk cultural customs, communication styles and identity in order to better serve Karuk tribal population.
- 3. Increase understanding of how historical trauma has affected Karuk individuals and families.
- 4. Increase understanding of how traditional ways of addressing stressors and healing practices can enhance behavioral health treatment.
