The Karuk Tribe requests proposals for the following Scope of Work required for provision of culturally focused small groups (face to face or virtual) for families.

Task One - Group Design and Curriculum Development

Coordination with Human Services clinical and administrative staff regarding selection of group/activity design and curriculum development.

Task Two - Provision of culturally focused groups related to tribal culture

Contractor is responsible for scheduling, preparation and facilitation of specific culturally focused groups for tribal individuals and their families.
