The Karuk Tribe requests proposals for the following Scope of Work for qualified vendors to provide Native and non-Native food harvest and preparation as an on-call contractual service for the Food Security Project during the fall, winter and spring seasons. Food harvest service will be needed mainly from the service areas from Happy Camp to Orleans, whereby food processing service – especially using water-bath and pressure canning methods – will be needed in all three service areas: Happy Camp, Orleans, and Yreka.

The Tribe will cover the expenses and supply all materials necessary to complete the services including but not limited to: cooking facilities, equipment, food preservation supplies and materials, and cleaning supplies.

It is the vendor's responsibility to remove trash and spill clean-up in the prep-kitchens; an overall clean-up of the kitchen will be required after each food preparation and preservation activity. Proposal responses must include labor costs and minor incidentals, such as mileage.

Those vendors with a valid Food Handler's certificate will receive preference, as it is our policy to have at least one certified Food Handler present at all times during food preparation and processing activities. All persons must exhibit professionalism, general courtesy and respect to all people, including Tribal staff.

Vendor shall respond to each communication regarding dates and locations for activities with their availability for service within one calendar week of notification. Vendor will be properly attired for activity, and work with other vendors for the time committed to service to achieve goals of each activity, be it harvesting or processing food. Each vendor will be equally responsible for removing trash and cleaning-up in the prep-kitchens after each food preparation and preservation activity.

### Responses to this Request for Proposals should include the following:

- 1) A statement of qualifications, including relevant project history. Please include your current Food Handler's certification documentation.
- 2) A proposed approach and rational for completion of the Scope of Work described above, including descriptions of similar work previously completed and the results/benefits achieved.
- 3) An hourly rate for requested services.
- 4) Names and telephone numbers of three client references.
