Bus Driver Responsibilities:

- 1. Shall inspect School Bus at the beginning of each AM bus route, using assigned bus inspection sheet.
- 2. Shall fuel bus as needed with no children aboard.
- 3. Shall be responsible for safe pick-up and delivery of Head Start children to and from the Center and field trips.
- 4. Shall develop and follow approved route to pick-up and delivery of children.
- 5. Shall monitor and supervise children while on the bus.
- 6. Shall use sign in and out sheets for safety of children and family assurance.
- 7. Shall keep interior and exterior of bus clean and free of unsafe hazards.

- 2. Shall observe students emotional, physical, and social development.
- 3. Shall assist in maintaining a positive environment that facilitates active learning, self-expression, and involvement of parents.
- 4. Shall contribute to the preparation of lesson plans for field trip planning.
- 5. Shall communicate with adults, families, and public.
- 6. Shall provide safety at all times for children.
- 7. Shall provide for classroom, bathroom, playground and field trip supervision of children, insuring that all children are in adult sight and reach at all times, when necessary.
- 8. Shall report suspicions of physical, social and emotional abuse or neglect of children.
- 9. Shall be available for local and out of the area travel as required for job related training. Shall attend all required meetings and functions as requested.
